#### 2. MANLY VOLUNTEER FIRE DEPARTMENT

- Fire Chief AJ Stone talked to the council regarding the generator at the fire station. The current generator needs to be replaced or rebuilt. Mayor O'Keefe asked AJ to get a cost to repair the generator, replacement cost and cost for a joint generator for the fire station and lift station.
- The fire department is considering replacing the 1999 International Engine 2 with a larger tanker. They plan to sell Engine 2, receive assistance from the township trustees and apply for a WCDA grant for the remainder of the cost.

#### 4. PUBLIC WORKS / LONNIE HILLMAN

#### 5. UPDATES

- Lights for Elmore Street project should be here in a couple of weeks.
- There will be new antennas installed on the blue water tower.
- Public Works will seed around Central Park
- There are some hairline cracks in the curb line on the Elmore Street project.
- Speed bumps on N. East St. will be removed for the summer.
- Pool repair on the leaking pipe has been completed and can be filled, one heater needs to be repaired.
   Councilman Tabbert suggested that when the pool closes at the end of the season, any items that need to be fixed be completed in the fall.
- Trees around Bosworth Park need to be trimmed.
- Keys for the concession at Macer-Dunn Youth Sports Complex have been given out to those who need them.
